**AT&T'S SECOND MOTION TO AMEND PROCEDURAL SCHEDULE**

By Order No. PSC-03-1265-PCO-TP, issued November 7, 2003, the Prehearing Officer established the procedural schedule to govern events in the above-referenced proceeding. On December 18, 2003, AT&T filed its Motion to Amend Procedural Schedule to modify the dates for filing Rebuttal and Surrebuttal Testimony. On December 22, 2003, the Commission issued Order No. PSC-03-1463-PCO-TP granting AT&T's Motion. However, neither AT&T's Motion nor the Commission's Order addressed the date for filing Prehearing Statements, which is scheduled for January 23, 2004. Under the current schedule, Prehearing Statements are due before the filing date for Surrebuttal Testimony – January 28, 2004.

Pursuant to Rule 28.106-204, Florida Administrative Code, AT&T Communications of the Southern States, LLC ("AT&T"), hereby respectfully moves the Prehearing Officer to modify certain of the procedural dates in this proceeding as follows:

	<u>Current</u>	<u>Proposed</u>
Prehearing Statements	January 23, 2004	February 2, 2004

All other procedural dates to remain the same. In support of its Motion AT&T states:

1. The instant proceeding was initiated in response to the Federal Communications Commission's August 21, 2003 Triennial Review Order (TRO). Pursuant to the TRO, state commissions must conduct a review of whether impairment exists with regard to local circuit switching for mass market customers. Such reviews must be complete within nine months from the TRO's effective date.


2. The issues raised in the TRO surrounding an assessment of whether impairment exists regarding local circuit switching are ones of first impression before this Commission. The analysis required to adequately respond to the questions raised in the TRO is exceedingly complex and requires the acquisition and review of very large amounts of technical information.

3. Parties filed Direct and Rebuttal testimony in this proceeding on December 4, 2003 and January 7, 2004, respectively. Pursuant to the Commission's December 22, 2003 Order, the date for filing Surrebuttal testimony is scheduled for January 28, 2004.

4. AT&T has had discussions with Commission Staff regarding the appropriate date for filing Prehearing Statements given the new testimony filing dates and this Motion requesting that the date for filing Prehearing Statements be rescheduled to February 2, 2004, which coincides with the date for filing Prehearing Statements in Docket No. 030852.

WHEREFORE, AT&T respectfully requests that the Commission modify the procedural dates for the filing of Prehearing Statements as set forth above.


