Registration of Intrastate Interexchange Telecommunications Company (IXC)**

NOW COMES Cornerstone Companies, LLC ("Cornerstone") and request withdrawal of its Registration of Intrastate Interexchange Telecommunications Company (IXC Registration) within the State of Florida. In support of this Application to Cancel IXC Registration the Applicant states as follows:

1. Cornerstone Companies, LLC was registered as an interexchange telecommunications company effective October 29, 2003 in Docket No. 031019-TI, and assigned IXC Registration Code TJ852.
2. Due to a change in the Company's business plan, Cornerstone no longer intends to initiate operations as a provider of interexchange telecommunications services within the State of Florida.
3. Cornerstone has not had and does not currently have any customers within the State of Florida, and, therefore, cancellation of Cornerstone's registration would not be disruptive to public convenience.
4. The Company is current on its Regulatory Assessment Fees pursuant to Section 364.336.

WHEREFORE, Cornerstone Companies, LLC respectfully requests that the Florida Public Service Commission ("Commission") cancel its IXC Registratio, and terminate it's tariff filed in compliance with Section 264.04.


