Re: CAT Communications International, Inc. Price Changes

Dear Ms. Bayo:

CAT Communications International, Inc. (CCI) is instituting some price changes that will affect the price point of the local residential service CCI provides in the state of Florida.

Currently, CCI is providing basic local residential service at \$39.95 per month, with one hour of long distance at no additional charge. CCI will begin in February 2004 charging \$39.99 for that service. The feature package previously available for \$5.00 will now be \$5.99. This price increase is not going to effect existing customers. It will be the service price for all new connects.

The long distance service is provisioned via 1+ dialing through a switch in New York State, purchased by CCI in 2003. One hour of service is provided at no additional charge to the customer and usage will be charged against that hour at \$0.079 per minute of use (MOU) for intrastate toll calls and \$0.049 per MOU for interstate toll calls. Additional time is available at the customer's request and will be post billed.

CCI will begin charging a Network Recovery Fee to mitigate the cost of its long distance switch. The fee will be \$0.99 for intrastate and \$0.99 for interstate.

The total price increase for new customers will be \$3.01 for basic service with the feature package and one hour of free long distance.

**3.1 Recovery Fees**

**3.1.1 Network Access Fee**

A rated adjusted fee based on the access charges paid by the Company to other local telephone companies.

**3.1.2 Intrastate Network Recovery Fee**

Monthly fee based on the maintenance and access fees for the provision of in state toll calling

**3.1.3 Interstate Network Recovery Fee**

Monthly fee based on the maintenance and access fee for the provision of out of state toll calling

3.6.4 Directory Assistance, cont.

A credit will be given for calls to Directory Assistance when:

1. The customer experiences poor transmission or is cut-off during the call,
2. The Customer is given an incorrect telephone number, or
3. The Customer inadvertently misdials an incorrect Directory Assistance NPA.

To receive a credit, the Customer must notify the Company operator or business Office of the problem experienced.

- Additional 1+ calling is available and will be post billed
- Toll blocks will be in effect to prevent the usage of 900; 700 per usage calls
- The customer will not be able to receive collect, third-party billed or any other type of per usage call.
- However, should the customer incur a pay per usage fee, the customer is solely responsible for payment of the fee.
- Taxes and other fees are not included in the quoted rates.
