

Joint Motion to Amend Procedural Schedule

Now comes BellSouth Telecommunications, Inc. ("BellSouth") and Sprint, Florida, Inc. ("Sprint") and the Citizens of Florida ("Citizens") who respectfully move that the procedural schedule in the above captioned matter be amended:


1. On January 20, 2004, the Florida Public Service Commission ("Commission") issued Order No. PSC-04-0056-PCO-TP establishing the procedure for this docket.
2. The procedure established for this docket is based on Section 120.57(1), Florida Statutes. BellSouth, Sprint and Citizens move that the procedural order in this matter be amended to become a hearing based on Section 120.57(2), Florida Statutes.
3. A joint stipulation of the record has been reached and filed with the Commission contemporaneously with this Motion. The Joint Stipulation would constitute the evidentiary record. Joint movants suggest that briefs be due in June, 2004, with the Staff Recommendation and Agenda to follow. Joint Movants further request that the filing, prehearing and hearing dates in Order No. PSC-04-0056-PCO-TP be eliminated.

4. Citizens, Sprint and BellSouth have spoken with Staff about the substance of this motion and Staff has no objection.

WHEREFORE, BellSouth, Sprint and Citizens respectfully request that this motion be granted and that Order No. PSC-04-0056-PCO-TP be amended to reflect the changes suggested herein.




