This is in response to Order No. PSC-04-0093-PAA-TX on January 27, 2004 in Docket No. 031014-TX. Please consider this a protest and/or offer of settlement.

On July 15, 2003, I wrote the Commission and requested cancellation of National Telecom, LLC'S CLEC certificate. On July 23rd, I received a fax from the Commission which advised me to pay the 2003 Regulatory Assessment Fee or provide a date certain it would be paid. The day before, I mailed a check, along with an application for withdrawal from the state. Unfortunately I have now discovered that the check and application for withdrawal was mailed to the Florida Department of State, Division of Corporations and not the Florida Public Service Commission.

Based on this inadvertent error, I respectfully ask that the Commission accept the company's 2003 Regulatory Assessment Fee return payment or the 2003 Regulatory Assessment Fee in full, and voluntarily cancel National Telecom, LLC'S CLEC certificate.


