

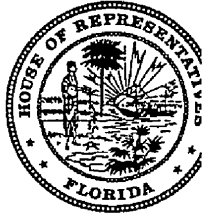



1. The docket number is 040086-EI and the name of the agency is the Florida Public Service Commission.

2. The Intervenor is the Office of Public Counsel, 111 West Madison Street, Room 812, Tallahassee, Florida 32399-1400, and is entitled to participate as a matter of statutory right under Section 350.0611(1), which authorizes the Public Counsel "to appear in the name of the state or its citizens, in any proceeding or action before the commission...."

3. Pleadings and other communications should be addressed to the Intervenor as:



5. The disputed issue of material fact is whether the Contract Service Agreement between TECO and Odyssey Manufacturing Company comports with the requirements of Order No. PSC-98-1081-FOF-EI, and whether that agreement serves the interests of TECO's aggregate customer base.
