Cable & Wireless USA, Inc. (C&W USA) hereby requests cancellation of the above-referenced certificates or authorizations to provide service in your state.

On December 8, 2003, C&W USA filed voluntary petitions for reorganization under Chapter 11 of the United States Bankruptcy Code in the US Bankruptcy Court for the District of Delaware. *See In re: Cable & Wireless USA, Inc., et al.*, Case No.03-13711 (GCG) (Bankr.D.DE.). As a result of this filing, certain of C&W USA's assets were purchased through the bankruptcy auction process. When the process of the transfer of those assets was completed on March 5, 2004, C&W USA was no longer providing telecommunications service in your state.

C&W USA has no customers in your state that will be impacted by this relinquishment request and therefore no customers to notify. Concurrent with the cancellation of its authority to provide telecommunications services in your state, C&W USA also respectfully requests that its intrastate tariffs be cancelled.

I had been dealing with LaRene Flack at Cable & Wireless about the company's local certificates (the AAV and CLEC). I'm surprised they've requested cancellation of just the AAV and the IXC and wonder if they realize the CLEC will still be active. I've checked RAFs and they paid 2003 AND 2004 RAFs on the AAV and CLEC. The IXC certificate has a 2003 credit of \$158.92 but the 2004 RAF has not been paid. The 2004 will need to be paid first IF they really want the IXC cancelled.

Brenda, Fiscal cannot transfer any credits/overpayments from one year to another. This means that if the company wants to cancel the IXC certificate, they will need to pay the 2004 RAF, then request a refund of the 2003 overpayment. I believe you need to talk with Ms. Flack to clarify exactly which certificates she wants cancelled before opening a docket.
