Dear Mr. Kunkle:

I just wanted to touch base with you concerning your December 15, 2003 letter requesting cancellation of the above company's IXC certificate. You called me on January 14<sup>th</sup> and stated that you had gotten in touch with the company and was told that the 2003 Regulatory Assessment Fee return, along with payment, would be returned to us by January 30, 2004.

As of this date, the Commission has not received the return form or payment. Since payment was not received timely, the company now owes an additional \$5 penalty and \$1 interest, for a total of \$56 for the 2003 fee. As information, the penalty and interest charges continue to accrue until the fee is paid. In addition, a docket to grant the company a voluntary cancellation cannot be opened until the company complies with the cancellation rule.
