RE: Voluntary Cancellation of Intrastate Interexchange Telecommunications
Registration

On March 5, 2004, this Commission received a request from One Call Communications, Inc. d/b/a Opticom, a Division of One Call Communications, Inc. d/b/a AdvantTel d/b/a 1-800-MAX-SAVE d/b/a RegionTel d/b/a LiveTel d/b/a SuperTel for removal from the IXC Registration List. Staff determined that the company needed to pay its 2003, and 2004 Regulatory Assessment Fees and any applicable penalties and interest as required in Section 364.336, Florida Statutes.

On March 30, 2004, One Call Communications, Inc. d/b/a Opticom, a Division of One Call Communications, Inc. d/b/a AdvantTel d/b/a 1-800-MAX-SAVE d/b/a RegionTel d/b/a LiveTel d/b/a SuperTel paid its 2003 and 2004 regulatory assessment fees plus all applicable penalties and interest. If One Call Communications, Inc. d/b/a Opticom, a Division of One Call Communications, Inc. d/b/a AdvantTel d/b/a 1-800-MAX-SAVE d/b/a RegionTel d/b/a LiveTel d/b/a SuperTel commences operations in Florida as an IXC, a new registration must be filed.

As required by Section 2.07.C.5.i, Administrative Procedures Manual, One Call Communications, Inc. d/b/a Opticom, a Division of One Call Communications, Inc. d/b/a AdvantTel d/b/a 1-800-MAX-SAVE d/b/a RegionTel d/b/a LiveTel d/b/a SuperTel, holder of IXC Registration TI917, has paid the required regulatory assessment fees and can be removed from the IXC Registration list effective 03/5/04.

Accordingly, with this Memorandum, Docket No. 040281-TI is hereby closed.
