Dear Mr. Winrow:

I received your April 21, 2004 fax with the April 19, 2004 attachment from Schaeffer Utility Management Co. describing the repairs to Sanibel Bayous Utility Corporation's (SBUC) wastewater plant. According to your letter, you have completed the fence installation, the overhaul of the lift station and the installation of new diffusers in aeration tanks. Please send copies of the invoices confirming the date this work was completed and the costs of the projects. I understand that the removal of the pond berm vegetation was begun this week. As each Commission ordered project is completed, please send the invoices confirming the cost and completion date.

By Order No. PSC-03-0699-PAA-SU, issued June 9, 2003, the Commission ordered that SBUC submit proof of insurance by September 29, 2003, and complete the surge tank, fence, lift station overhaul, the removal of vegetation from the pond berm, the addition of baffles in the chlorine contact chamber and the addition of new diffusers in some of the aeration tanks by January 1, 2004. It is my understanding through conversations with Mr. Carson Schaeffer, that the surge tank and the addition of baffles may no longer be required by the Department of Environmental Protection. If this is correct, then SBUC should provide supporting evidence and file a petition with the Public Service Commission seeking relief from these requirements.


