Request for permission from Department of Financial Services to Write Off the RAFs for the years 2001, 2002, and 2003 for Essential.com, Inc. (TJ320, TX420)

On July 29, 2003, Docket No. 030674 was established to address Essential.com, Inc.'s (Essential) failure to remit RAF's for the years 2001, 2002, and 2003. By Order No. PSC-03-1058-PAA-TP, issued on September 23, 2003, the Commission approved the cancellation of Essential's Interexchange Telecommunications (IXC) Registration No. TJ320 and Competitive Local Exchange Telecommunications (CLEC) Certificate No. 7342. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Department of Financial Services for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write off the uncollectible amount.
