**GTC, Inc. d/b/a GT COM NOTICE OF INTENT TO REQUEST SPECIFIED  
CONFIDENTIAL CLASSIFICATION**

GTC, Inc. d/b/a GT Com ("GT Com") hereby files, pursuant to Rule 25-22.006, F.A.C., this Notice Of Intent to Request Specified Confidential Classification ("Notice") and states as follows:

1. On April 30, 2004, PSC Staff requested certain data relating to matters raised in the Petition filed by GT Com filed in the above cause.

2. Specifically, Staff requested as follows: "[I]n response to Data Request No. 5, GT Com states that its parent company has executed agreements with NeuStar and Verisign to provide ancillary support for LNP. Please provide copies of these agreements."<sup>1</sup> The agreements that GT Com's parent company has executed with NeuStar and Verisign contain information related to rates, terms, costs and other information that is (or may be considered) proprietary and confidential. As a result, the contents of GT Com's parent company's agreements with NeuStar and Verisign are not being filed with the Petition. Instead, the responses to such requests are enclosed with this Notice.

3. Because of the proprietary and confidential nature of the information, GT Com is filing this Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006 (4), F.A.C., in order to allow the Commission to take possession and review the confidential information without delay.

4. GT Com respectfully requests for the Commission to maintain the confidentiality of the confidential information contained herein pending the establishment of final protective measures.
