PURPOSE AND PROCEDURE

The purpose of this hearing is to consider the application of Farnton Water Resources LLC for a certificate to provide water service in Volusia and Brevard Counties and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on May 17, 2004. All witnesses shall be subject to cross-examination at the conclusion of their testimony.


APPLICABLE STATUTES AND RULES
