As required by Section 2.07.C.2.a, Administrative Procedures Manual, this is to inform you that I concur with the name change on CLEC Certificate No. 8405.

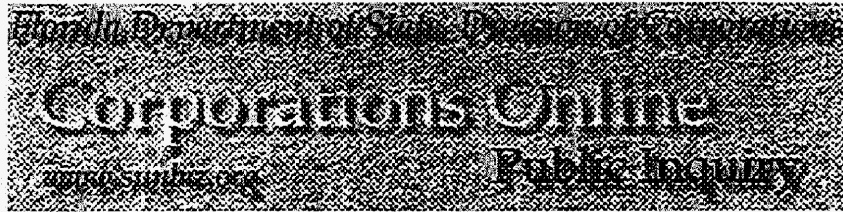

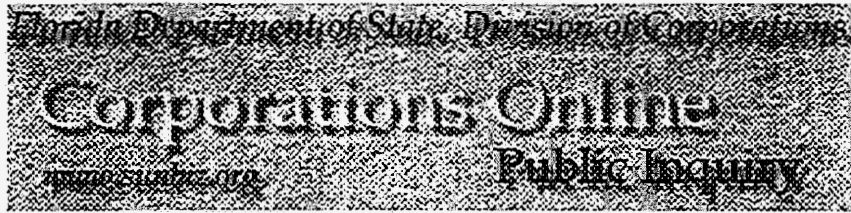
