RE: Docket No. 040476-TI; Voluntary Cancellation of Intrastate Interexchange Telecommunications Registration

On April 14, 2004, this Commission received a request from RCN Telecom Services, Inc. (f/k/a RCN Telecom Services of Pennsylvania, Inc.) for removal from the IXC Registration List, effective April 14, 2004. Staff has determined that the company has paid all previous years' regulatory assessment fees minus applicable penalties and interest as required in Section 364.336, Florida Statutes.

RCN Telecom Services, Inc. (f/k/a RCN Telecom Services of Pennsylvania, Inc.) is subject to the regulatory assessment fee for the final year or portion thereof as a registered IXC. The company has indicated that its 2004 RAFs payment will be submitted within 30 days after the issuance of the Order. If RCN Telecom Services, Inc. (f/k/a RCN Telecom Services of Pennsylvania, Inc.) commences operations in Florida as an IXC, a new registration must be filed.

As required by Section 2.07.C.5.i, Administration Procedures Manual, RCN Telecom Services, Inc. (f/k/a RCN Telecom Services of Pennsylvania, Inc.) holder of IXC Registration No. TJ321, will submit its 2004 RAF payment within 30 days after the issuance of the Order and can be moved from the IXC Registration list effective April 14, 2004.

Accordingly, with this Memorandum, Docket No. 040476-TI is hereby closed.
