Hi Sue. It looks like this one fell through the cracks. On January 20, 2004, the Commission received a letter from Ms. Gentry requesting cancellation of its CLEC certificate and specifically listed Certificate No. 5263. CCA sent the letter to me because Cert. No. 5263 belonged to the company's IXC certificate (T1700). I e-mailed Ms. Gentry on the same date and explained we needed clarification that she wanted TX180 or T1700 cancelled before the request for cancellation could be docketed. I also explained that the 2003 Regulatory Assessment Fee would have to be paid before a voluntary cancellation could be recommended. She confirmed that the company wished to cancel TX180, Cert. No. 5612 and said the 2003 Regulatory Assessment Fee was in the mail.

I forwarded the e-mail to Jackie Gilchrist in Certification who advised CCA to wait until payment was received before opening a docket, which is standard operating procedure. Unfortunately, to my knowledge, we were not notified that payment had been received on January 21 (the very next day). Since I had turned it over to Jackie, I filed my copy and did not follow up for payment. And, although I can't speak for Jackie, I believe she was probably waiting to be notified that payment had been received.

Bottom line on TX180 -- the certificate should be voluntarily cancelled with an effective date of 12/31/03 since the 2003 RAF was paid by the due date of January 30th. Jackie, can you have this docketed as soon as possible? The original document number is 00744-04.

Sue, I hope this answers your questions/concerns. Let me know if you need anything else from me.

My company is Adelpia Telecommunications of Florida, Inc we previously had a CLEC certificate under TX180-5612 which we voluntarily returned in January 2004. I worked with Paula Isler to cancel our CLEC CPCN. We had never operated as a CLEC in Florida only as a reseller of LD to residential customers. We are a wholly owned subsidiary of Adelpia Communications Corporation, the cable company that has franchises in Florida.

There is another company with a similar name, Adelpia Business Solutions or a variation of that name that may have or currently may provide local service in Florida. We are frequently confused with them and as such I have forward queries to their regulatory/legal group on specific issues when our identity is confused.
