In connection with the above-referenced docketed matter, on behalf of New Century Telecom, Inc. ("NCT") (Docket No. 040062-TI), it is respectfully requested that the Commission's consideration of Staff's Recommendation, scheduled for June 29, 2004, be deferred.

Pursuant to a May 14, 2004 request of Optical Telephone Corporation ("Optical") in Docket No. 040289-TI, the Commission deferred the consideration of all of the above-referenced dockets from its May 18, 2004 Agenda to its June 29, 2004. Consistent with that deferral, Staff's Recommendation is all dockets was deferred to June 17, 2004. On June 17, 2004, Staff issued its Recommendation in NCT's docket. However, according to the electronic docket information available on the Commission's website, the date for Staff's Recommendation in Optical's docket has been delayed again to July 22, 2004 and the Agenda deferred until August 3, 2004.

Throughout these entire proceedings, Staff has dealt with the above-dockets as one interrelated matter. In fact, the reason Staff initially gave to NCT's counsel for its inability to negotiate a settlement with NCT was the involvement of these other companies and dockets. Moreover, because Staff's recommendation is based on some perceived "consortium" between NCT, Optical and several other companies. NCT submits that the Commission must consider these dockets together and that NCT must be allowed the opportunity to review Staff's Recommendation in the Optical proceeding, not scheduled until July 22^{nd} , and any facts and conclusions relied upon by Staff therein, before the Commission can consideration the recommendation on NCT.

Therefore, NCT requests that the Commission defer its consideration of Staff's Recommendation from June 29, 2004 until August 3, 2004.
