**RE: Docket No. 031016-TX; Application of STS Telecom, LLC for Authority to Provide Competitive Local Exchange Services within the State of Florida**

Dear Mr. Bayo:

On October 28, 2003, STS Telecom, LLC filed with the Commission an application for authority to provide competitive local exchange service in the above-referenced docket. In Order No. PSC-04-0031-CO-TX, the Commission approved the application and closed the docket.

STS Telecom recently discovered that an inadvertent error was made in its Application filed in this proceeding. Specifically, in item 15(a), the Application indicated that none of STS Telecom's officers, directors, or any of the ten largest stockholders had previously been "adjudged bankrupt, mentally incompetent, or found guilty of any felony or of any crime, or whether such actions may result from pending proceedings." In fact, on November 26, 1997, Mr. Mark Amarant, an officer and part owner of STS Telecom, LLC, filed a Chapter 13 (reorganization) petition for personal bankruptcy. Mr. Amarant's plan for repayment was issued on January 23, 1998, a notice of the plan's completion was issued February 21, 2001, and an Order of Discharge issued on February 22, 2001.
