

JOINT MOTION FOR EXTENSION OF TIME

BellSouth Telecommunications, Inc. ("BellSouth") and IDS Telecom, LLC ("IDS"), pursuant to Rule 28-106.204(5), Florida Administrative Code, jointly request that the Florida Public Service Commission ("Commission") grant all parties an extension of time until July 22, 2004 to file direct testimony and until August 12, 2004 to file rebuttal testimony in this docket. In support of this Motion, the parties state the following:

1. Currently, direct testimony is due on July 15, 2004 and rebuttal testimony is due on August 9, 2004.
