- 1. Contract. Pursuant to Rule 25-30.037(2)(g) and (h), F.A.C., the application is to contain a copy of the contract between the seller and buyer of the utility. The rule is very specific regarding the minimum requirements of such a contract. The contract did not contain any information as to the disposition of the "customer deposits interest." Please provide an addendum to the contract for Sale and Purchase, signed by the two parties, which addresses the customer deposits interest.
- ECR 2. Financing. Pursuant to Rule 25-30.037(2)(i) and (k), F.A.C., the application is to contain specific information as to the amount of the purchase price which is being financed, the GCL terms of the financing, and those entities being relied upon for financing. The deficiency OPC response stated that the "purchase price for Alturas Utilities, LLC is \$40,000," however, the Contract for Sale and Purchase shows the purchase price to be \$45,000. Please MMS provide the correct purchase price for the Alturas system. RCA
- 3. Public Interest. Pursuant to Rule 25-30.037(2)(j), F.A.C., the application is to contain a convincing statement as to how the transfer is in the public interest, including a showing of the Buyer's financial ability. Please provide a convincing statement as to why the sale of the system is in the public interest. In addition, the letter from Turnberry Bank does OTH not satisfy the requirement of the showing of the buyer's financial ability. Please provide

Please provide a statement regarding how Ms. Chambers' departure from Keen will impact the contract for transfer and how Mr. Sheldon intends to demonstrate his technical ability to run the utility.
