NOTICE OF PROPOSED AGENCY ACTION
ORDER CANCELLING COMPETITIVE LOCAL EXCHANGE
TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Adelphia Telecommunications of Florida, Inc., (Adelphia) holder of Competitive Local Exchange Telecommunications (CLEC) Certificate of Public Convenience and Necessity No. 5612, has requested the cancellation of CLEC Certificate No. 5612. Adelphia has complied with the provision of Rule 25-24.820(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its CLEC certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2003. Accordingly, we find it appropriate to cancel CLEC Certificate No. 5612, effective December 31, 2003. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Adelphia Telecommunications of Florida, Inc.'s Certificate No. 5612 to provide Competitive Local Exchange Telecommunications services is hereby canceled, effective December 31, 2003. It is further


