1. On June 28, 2004, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX Code Denial for the Miami exchange (Red Road), along with Attachments 1 and 2. Attachments 1 and 2 contain information that is considered confidential and proprietary to BellSouth. A Notice of Intent to Request Specified Confidential Classification for those attachments was also filed on the same day.
