## DIECA Communications, Inc., d/b/a Covad Communications Company Motion for Extension of Time

DIECA Communications, Inc. d/b/a Covad Communications Company (Covad), pursuant to rule 28-106.204, Florida Administrative Code, files this Motion for Extension of Time. As grounds therefore, Covad states:

- 1. On June 23, 2004, Covad filed a petition for arbitration with BellSouth Telecommunications, Inc. (BellSouth) regarding line sharing. In that petition, Covad requested that the Commission find that BellSouth is required to provide line sharing pursuant to § 271 and that line sharing must be offered at just and reasonable rates.
- 2. On July 19, 2004, BellSouth filed what it denominated a "response" to Covad's petition. While BellSouth calls its pleading a "response," it is actually a motion to convert<sup>1</sup> this proceeding into a different type of proceeding than that which Covad requested<sup>2</sup> and to arbitrate a number of issues which the parties have not yet negotiated.
- 3. Thus, it is Covad's position that BellSouth's "response" is actually a motion and an arbitration request, both of which require a response from Covad.
- 4. Because BellSouth's "response" was served by federal express, Covad's response would be due on July 27, 2004.

- 5. However, counsel for Covad has several other pressing matters to which he must attend and will be out of town during the next seven day period. Therefore, Covad requests an extension of time to properly address BellSouth's "response."
- 6. Covad requests that it have up to and including August 6, 2004 to address BellSouth's "response." Neither party will be prejudiced by this brief extension.
- 7. Counsel for Covad has contacted counsel for BellSouth and is authorized to represent that BellSouth has no objection to the requested extension.

**WHEREFORE**, Covad requests that its Motion for Extension of time up to and until August 6, 2004 be granted.
