Dear Mr. Eubanks:

Attached is a copy of the application for Holiday Utility Company, Inc. (Holiday), for a transfer and amendment in Pasco County. The amendment portion of the application includes both a proposed addition and deletion of territory. Maps of the proposed areas, along with updated versions of the territory descriptions, are also included. Pursuant to the Memorandum of Understanding between the Department of Community Affairs (DCA) and Public Service Commission (PSC), the DCA has agreed to provide input on need for service and comprehensive plan consistency on applications for amendments or original certificates.

The filing of Holiday is the ninetieth filing to receive this treatment. Staff Requests that a response from the DCA be received by August 25, 2004. **Please note that the response should be addressed to the Division of Commission Clerk & Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399-0850, with the docket number highlighted for reference by the Commission.**

On June 15, 2004, the Commission received a letter from Pasco County, objecting to the utility's application. The County's protest appears to be based on concerns over Holiday's encroachment into Pasco County's service area. A copy of the County's objection letter is attached. This case has not yet been set for hearing. Should that happen, the DCA will be updated by the PSC staff assigned to the case.


