PURPOSE

The Florida Public Service Commission has jurisdiction over the determination of overall suitability of ten-year site plans pursuant to Section 186.801, Florida Statutes. The purpose of this workshop is to afford an opportunity for public comment on the ten-year site plans submitted by Florida's utilities. At the workshop, the utilities will describe their plans, the key assumptions underlying the plans, and the impact of demand-side management goals on the plans. The Florida Reliability Coordinating Council will present the Peninsular Florida Regional Load and Resource Plan.


