Dear Mr. Collins:

Our records show that Inacom Communications, Inc. holds IXC Registration No. TI258 and that it filed for Chapter 11 bankruptcy protection on June 16, 2000. The 2000, 2001, 2002, and 2003 Regulatory Assessment Fees, including statutory penalty and interest charges and which are due annually by January 30th, have not been paid. It appears that only the 2000 Regulatory Assessment Fee would be considered pre-petition debt. The Regulatory Assessment Fee continues to accrue until a registration is cancelled. For example, the 2004 fee will become due January 30, 2005.

I also researched the Florida Department of State, Division of Corporations' records and found that Inacom Communications, Inc.'s status in Florida was revoked effective September 22, 2000, for not filing its annual report. This means that the company must have Inacom Communications, Inc. reinstated with the Florida Department of State if it wishes to keep its IXC registration active.

If the company does not have need of its registration in Florida, it can write the Commission a letter and request cancellation of the registration due to the bankruptcy and ask us to write-off any unpaid fees. I would appreciate your review of this information and let me know the company's intention to continue to provide service in Florida by July 30, 2004.
