Progress Energy Florida, Inc. (Progress Energy) and Withlacoochee River Electric Cooperative, Inc. (WREC), pursuant to Order No. PSC-04-0339-PCO-EU granting Progress Energy's Agreed Upon Motion to Toll Time, file this Joint Status Report and state as follows.

The settlement negotiations described in the Agreed Upon Motion to Toll Time and the parties' previous Joint Status Report remain ongoing. Since the prior Status Report, WREC and Progress Energy have held additional settlement conferences, each of which was preceded and followed by telephone discussions on various related issues. The negotiations have led to the exchange of several specific settlement proposals, and the parties are continuing their efforts to identify and explore various components and combinations thereof capable of providing a properly balanced, mutually acceptable settlement package.

The parties expect that the settlement negotiations should conclude within the next 60 days, recognizing either party may terminate the negotiations at any time if it concludes a successful outcome to be unlikely by filing the seven-day DOCUMENT NUMBER.
