COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, and files this Request for Specified Confidential Classification.

1. On July 14, 2004, BellSouth filed its Response to the Florida Public Service Commission Staff, hereinafter ("Staff")'s Second Set of Interrogatories (Nos. 17-29) and Second Request for Production of Documents (Nos. 7-11).

2. Because BellSouth's Response to the Staff's Second Request for Production of Documents No. 7, in particular a proprietary CD ROM, contains confidential business, proprietary information, BellSouth also filed a Notice of Intent on July 14, 2004. A more specific description of this information is provided in Attachment A. This CD ROM should be classified as proprietary, confidential business information pursuant to Section 364.183(3)(e), Florida Statutes and is exempt from the Open Records Act.

3. Attachment B to BellSouth's Request for Confidential Classification is redacted copies of the documents containing the confidential information.

4. Attachment C to BellSouth's Request for Confidential Classification is a highlighted copy of the document containing the confidential information.




