**RE:** Docket No. 040790-TP, Petition for Expedited Review of Growth Code Denial by the Number Pooling Administrator for the DeLand Exchange (Main), by BellSouth Telecommunications, Inc.

On July 27, 2004, BellSouth filed a petition requesting that the Commission overturn NeuStar's decision to deny numbering resources for the Main switch (DELDFLMADS0) located in the DeLand rate center. In accordance with Commission Order PSC-02-0352-PAA-TL, which approved an expedited process for code denials, we have examined the BellSouth petition, along with the confidential supplemental information, and have determined the following:

- 1) The carrier has demonstrated that it has a customer in need of immediate numbering resources;
- 2) The carrier has shown that it will be unable to provide services to a potential customer because of the Pooling Administrator's denial of the numbering resources; and
- 3) A potential customer cannot obtain service from the provider of his/her choice because the carrier does not have the numbers available.
