**Amendment to the Agreement
Between
LecStar Telecom, Inc.
and
BellSouth Telecommunications, Inc.
Dated January 1, 2003**

Pursuant to this Amendment, (the "Amendment"), LecStar Telecom, Inc. (LecStar), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated January 1, 2003 ("Agreement") to be effective thirty (30) calendar days after the date of the last signature executing the Amendment.

WHEREAS, BellSouth and LecStar entered into the Agreement on January 1, 2003, and;


NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:


1. The Parties agree to add as Section 5.1.2 to Attachment 2 of the Agreement the terms and conditions from Section 2.16.7 in Attachment 2 of the Supra Telecommunications and Information Systems, Inc.'s Interconnection Agreement dated July 15, 2002, as set forth below:
 - 5.1.2 Where a BellSouth voice customer who is subscribing to BellSouth FastAccess Internet Service converts its voice service to LecStar utilizing a UNE-P line, BellSouth will continue to provide FastAccess service to that user.
2. All of the other provisions of the Agreement, dated January 1, 2003, shall remain in full force and effect.
3. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
