Dear Ms. Jones:

I hope that you will be able to assist me. I got your name from the US Bankruptcy Court, District of Delaware's Voice Case Information System, which advised you are the attorney for the above debtor.

Our records show that STAR Telecommunications, Inc. holds IXC Registration No. TJ006 and that it filed for Chapter 11 bankruptcy protection on March 13, 2001. The company owes the 2001, 2002, and 2003 Regulatory Assessment Fees, along with statutory late payment charges for the years 1999, 2000, 2001, 2002, and 2003. It appears that only the 2000 Regulatory Assessment Fee would be considered pre-petition debt. The Regulatory Assessment Fee continues to accrue until a registration is cancelled. For example, the 2004 fee will become due January 30, 2005.

I also researched the Florida Department of State, Division of Corporations' records and found that STAR Telecommunications, Inc. was revoked effective October 4, 2002, for not filing an annual report. This means that the company must have STAR Telecommunications, Inc. reinstated with the Florida Department of State if it wishes to keep its IXC registration active.

If the company is no longer in business and does not have need of its registration in Florida, can you write the Commission a letter and request cancellation due to the bankruptcy and ask us to write-off any unpaid fees? I would appreciate your review of this information and let me know the company's intention to continue to provide service in Florida by August 6, 2004.
