Mr. David Slavens, doing business as The Computer Guy of NW Florida, Inc. (The Computer Guy) has requested through Attorney Mark Welton a voluntary withdrawal of the complaint he filed May 7, 2004 against Sprint-Florida (Sprint) for alleged default on a contract commencing May 1, 2004 between The Computer Guy and Sprint for installation and maintenance of Channelized T1s (PRIs). Mr. Welton emailed a letter to Counsel at the Florida Public Service Commission on August 3, 2004 stating that The Computer Guy is no longer in business (see attachment).
