We have reviewed the minimum filing requirements filed on behalf of the above mentioned utility and found them to be deficient. The specific deficiencies are identified below:

- 1. Schedule B-5, Schedule of operation and maintenance expenses: This schedule should indicate the monthly balances for all three years, 2003, 2004, and 2005. The utility only indicated the total annual amounts.
- 2. Schedule B-7, Rate case expense schedule: Not completed by utility. This schedule should provide the amount of requested rate case expense, as well as, a list of each firm providing service, the hourly rate, total charges, and a description of the type of service provided.
- 3. Schedule E-1, Schedule of present and proposed rates: Not completed by utility. This schedule should indicate the utility's present wastewater service rates, as well as, it's requested wastewater rates. The proposed rates should result in the utility's proposed revenue requirement in its projected test year, 2005.
- 4. Schedule E-2, Revenue schedule at present and proposed rates: Not completed by utility. This schedule should provide a calculation of revenues at both present and proposed rates using the utility's billing analysis.
  - 5. Schedule E-5, Projected test year revenue calculation: Not completed by utility. This 4 schedule should provide a calculation of historical and projected bills and consumption, as well as projected test year revenue.
- 6. Schedule E-6, Billing analysis: Not completed by utility. This schedule should  $\Xi$ provide a billing analysis for each class of service. If the utility is proposing a rate schedule change, i.e. flat to metered rate, consumption data must be reported for both the historical and projected test years. <u>0</u>00

- 7. Schedule F-2, Schedule of gallons of wastewater treated or <u>purchased</u>. Not completed by utility.
- 8. Schedule F-9, Schedule of average customer growth: Not completed by utility. This schedule should provide the number of customers for the past 5 years.
- 9. A petition for rate relief which contains the general information required by Rule 25-30.436(1), Florida Administrative Code (F.A.C).
- 10. The signed affidavit which states the utility will comply with Rule 25-22.0407, F.A.C., as required by Rule 25-30.436, F.A.C.
- 11. A detailed map showing the location of the applicant's collection lines and classification of customers, as required by Rule 25-30.440(1), F.A.C.
- 12. A list of all customer complaints received during the test year, as required by Rule 25-30.440(10), F.A.C.

Please submit sixteen (16) copies of the required pages for items 1 through 12, above, (Rule 25-30.436(4)(d), F.A.C.). Your petition will not be deemed filed until we have received the above mentioned information. These corrections should be submitted no later than October 29, 2004.
