Peoples Gas System ("PGS"), by its undersigned attorneys, submits the following Preliminary List of Issues and Positions:

Generic Purchased Gas Adjustment Issues

ISSUE 1: What are the appropriate final purchased gas adjustment true-up amounts for the period January 2003 through December 2003?

PGS: \$7,268,762 underrecovery

ISSUE 2: What are the estimated purchased gas adjustment true-up amounts for the period January 2004 through December 2004?

PGS: \$10,448,229 overrecovery

ISSUE 3: What are the total purchased gas adjustment true-up amounts to be collected or refunded during the period January 2005 through December 2005?

PGS: \$3,179,465 overrecovery

ISSUE 4: What are the appropriate levelized purchased gas cost recovery (cap) factors for the period January 2005 through December 2005?

PGS: \$0.99037 per therm

ISSUE 5: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

PGS: The factor should be effective for all bills from the first billing cycle in January 2005 through and including the last billing cycle in December 2005.


