The application remains deficient pursuant to Chapter 367 Florida Statutes and Rule 25-30.037, Florida Administrative Code (F.A.C.). All deficiencies must be corrected in order for staff to process your application. Also, additional information is needed to clarify portions of your application.

Noticing. As required by Section 367.045(1)(a), Florida Statutes, and Rule 25-30.030, F.A.C., the utility must provide notice of the application and provide affidavits that the notice was given. The notice must be given to each customer of the utility. The notice must also be given to all cities located in the county, to specific governmental entities and all utilities in the county which are included on the noticing list provided by the Public Service Commission. It appears that neither of these notices have been issued. The copy of a customer letter provided is not in the proper noticing format. The copy of the notice for all cities located in the county, to specific governmental entities and all utilities in the county was in proper format, however the copy of the list provided as proof of noticing expired on October 27, 2003.

Based upon the reasons stated above, please renounce the customers and the entities on the enclosed noticing list for Polk County. Please submit proper affidavits for the notices and attach a copy of the notice to each affidavit along with a copy of the list of entities receiving the notice. The noticing list and a sample of proper affidavits for the two notices are enclosed. Remember that where the notice states "Notice is hereby given on month day, year, you must enter the actual date the notices are mailed. Also, be certain that the notice states that "objections must be filed with the Director, Division of the Commission Clerk and Administrative Services." Questions about the notice or the

 - ✓ Original Sheet No. 5.0 – Enter the full name of the utility for Term No. 5.0.
 - ✓ Original Sheet No. 12.0 – Delete “Plus Polk County 8% Sales Tax.
 - ✓ Original Sheet No. 16.0 – Add to the list of charges - \$2.00 Late Payment Fee.
 - ✓ Original Sheet No. 19.0 – Attach a copy of Customer’s Guarantee Deposit Receipt.
 - ✓ Original Sheet No. 22.0 – Attach a Copy of Customer Bill for Alturas customers.
 - ✓ Original Sheet No. 24.0 – Enter portion of Service Availability Policy from Keen tariff that applies to Alturas.
2. Tariff. You have stated that the name of the utility formed after the purchase of the Alturas system is Alturas Utilities, LLC. The tariff was generated in the name of Sunrise Utilities, LLC d/b/a Alturas Utilities, LLC. Please resubmit the entire tariff in the correct name, with the corrections listed above.
3. Audit Report. Do you intend to file a response to the audit report? If you do, it must also be received no later than November 19, 2004.


