

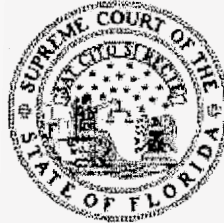
Appellees' Joint Motion to Strike AARP's Notices of Supplemental Authority which was filed with this Court on October 7, 2004, is hereby denied as moot.
