The OL-2 and OI-3 rates complement the OL-1 rate which the Commission has already approved. The Decorative Lighting Rate is designed for subdivisions served by underground facilities.

CANCELLING FIRST REVISED SHEET NO. 17.1**

NAME OF UTILITY: GLADES ELECTRIC COOPERATIVE, INC.

**RATE SCHEDULE OL-1
OUTDOOR LIGHTING**

APPLICABILITY

Applicable to all members for year-round outdoor lighting of yards, driveways, walkways, highways, roads and other areas by high pressure sodium lamps. Lights should be at locations which are easily and economically accessible to Cooperative equipment and personnel for construction and maintenance.

All outdoor lights should be installed on existing facilities (where possible) or short extensions thereto, in areas where a lighting system is either not provided or is not sufficient to cover the lighting needs of a particular consumer or location.

Where existing Cooperative-owned poles are deemed not adequate or suitable by either of the parties to this agreement, the Member agrees to furnish an easement for any additional poles required and necessary right of way. The Member agrees to permit any tree trimming required for service conductors and lighting units or units. The Member agrees that where he/she is the owner of the land, he/she will grant an easement to the Cooperative for the purpose of installing poles, lines and all necessary electrical connections. Where the Member is not the owner of the land, the Members agrees to procure the consent of the owner of said property, and where such consent is necessary, the Member agrees to procure the signature of the owner.

CHARACTER OF SERVICE

Single-phase, 60 cycles, at available voltages. Service includes lamps, energy from approximately dusk each day until approximately dawn the following day, and maintenance of facilities. The Cooperative will replace all burned-out lamps and will maintain its facilities. Maintenance of outdoor or street lights will normally be performed only during regular business hours and as soon as practical following notification by the member.

NAME OF UTILITY: GLADES ELECTRIC COOPERATIVE, INC.

**SCHEDULE OL-1
OUTDOOR LIGHTING**

The Cooperative will maintain all outdoor or street lights at no cost to the member when failure of such fixture is due to normal failure or action of the elements. Upon determining that a light has been maliciously or intentionally damaged, management may require payment of a Repair Charge, in the amount of \$50.00, by the consumer of record. The second such occurrence of damage shall require the same Repair Charge and upon the third such occurrence, the Cooperative may elect to remove its lighting facilities and notify the consumer that lighting facilities are no longer available at or near this location.

The Cooperative, while exercising reasonable diligence at all times to furnish service hereunder, does not guarantee continuous lighting and will not be liable for damages for any interruption, deficiency or failure of service, and reserves the right to interrupt service at any time for necessary repairs to lines or equipment.

MONTHLY CHARGES:

All the following charges (except L3) include a 30 ft. class 6 wood pole if needed. L3, Town and Country Light includes one Concrete, Aluminum or Fiberglass pole.

NAME OF UTILITY: GLADES ELECTRIC COOPERATIVE, INC.

**SCHEDULE OL-1
OUTDOOR LIGHTING**

No credit shall be allowed for lamp outages.

For lighting service, energy charges included in the above rates are based on wattage of the lamp X 12 hours per day operation X 30 days in the month.

TAXES AND FEES

Taxes and fees imposed by governmental authorities on the basis of meters, revenues, energy sold, or energy purchased shall be added to the monthly charge as applicable.

UP FRONT FEES AND DEPOSITS

There shall be no up front fees or deposits under this rate on the initial request for outdoor lighting. Deposits may be required by management when it is necessary to disconnect and reconnect service for non payment.

METERED SERVICES

There shall be no metered services under this rate. See Outdoor Lighting Rate O-2 for metered services of Member owned lighting systems.

**RATE SCHEDULE OL-2
OUTDOOR LIGHTING SERVICE**

APPLICABILITY

Applicable to all members for year-round outdoor lighting of yards, driveways, walkways, highways, roads and other areas by any type of member owned and maintained lighting system.

Cooperative-owned poles and facilities will not be used by the Member under this rate.

CHARACTER OF SERVICE

Single-phase, 60 cycles, at available voltages. Service includes power supply to the metering point as provided by the Member. The Member is responsible for all permits and inspections by the local governmental authority before the meter can be installed.

All maintenance of the lighting system, poles, fixtures, lamps, meter base and all other pertinent equipment will be provided solely by the member/owner of the lighting system.

The Cooperative, while exercising reasonable diligence at all times to furnish service hereunder, does not guarantee continuous lighting and will not be liable for damages for any interruption, deficiency or failure of service, and reserves the right to interrupt service at any time for necessary repairs to lines or equipment.

MONTHLY CHARGES:

Service Charge	\$10.50 per month
Energy Charge	\$ 0.086 per kWh

This rate is to be used solely for metering member owned lighting system. Other equipment, including pumps, motors, facilities, etc. is prohibited from being metered on this rate.

**RATE SCHEDULE OL-3
OUTDOOR LIGHTING SERVICE**

APPLICABILITY

Applicable to members where the energy used for lighting is through an existing meter. Final determination of applicability rests solely with the Cooperative. All fixtures are for year-round outdoor lighting of yards, driveways, walkways, highways, roads and other areas by high-pressure sodium lamps. Fixtures and/or poles will be installed only at locations that are easily and economically accessible to Cooperative equipment and personnel for construction and maintenance.

All outdoor lights should be installed on existing facilities (where possible) or a short extension thereto, in areas where a lighting system is either not provided or is not sufficient to cover the lighting needs of a particular consumer or location. Additional poles will be charged at the rates shown and in the event that additional transformers are needed, the direct cost of the equipment will be paid before construction commences.

Where existing Cooperative-owned poles are deemed not adequate or suitable by either of the parties to this agreement, the Member agrees to furnish an easement for any additional poles required and necessary right of way. The Member agrees to permit any reasonable tree trimming required for service conductors and lighting units or poles. Extensive right of way trimming will be charged at the direct cost to the member and paid before construction commences. The Member agrees that where he/she is the owner of the land, he/she will grant an easement to the Cooperative for the purpose of installing poles, lines and all necessary electrical connections. Where the Member is not the owner of the land, the Member agrees to procure the consent of the owner of said property, and where such consent is necessary, the Member agrees to procure the signature of the owner before construction commences.

MEMBER OWNED DISTRIBUTION SYSTEM

In the event that the distribution system on the load side of the meter is owned by the member, the member agrees to grant an easement to GEC for the purpose of installing any additional poles, equipment and fixtures. The member also agrees to provide any permits required by municipal or county agencies. All wiring performed by employees of GEC will be standard installation practices for the purpose of outdoor lighting only. Member also agrees that the outdoor lighting program is a lease program and all fixtures, poles and equipment remains the property of Glades Electric Cooperative.

Maintenance of outdoor or street lights will normally be performed only during regular business hours and as soon as practical following notification by the member.

The Cooperative will maintain all leased outdoor or street lights at no cost to the member when failure of such fixture is due to normal failure or action of the elements. Upon determining that a light has been maliciously or intentionally damaged, management may require payment of a Repair Charge, in the amount of \$50.00, by the consumer of record. The second such occurrence of damage shall require the same Repair Charge and upon the third such occurrence, the Cooperative may elect to remove its lighting facilities and notify the consumer that lighting facilities are no longer available at or near this location.

The Cooperative, while exercising reasonable diligence at all times to furnish service hereunder, does not guarantee continuous lighting and will not be liable for damages for any interruption, deficiency or failure of service, and reserves the right to interrupt service at any time for necessary repairs to lines or equipment.

All the following charges (except L3) include a 30-ft. class 6 wood pole if needed. L3, Town and Country Light include one Concrete, Aluminum or Fiberglass pole.

Special equipment (including transformers) that is necessary for the proper operation of outdoor lighting fixtures will be charged at the direct cost of equipment and labor installation.

No credit shall be allowed for lamp outages.

For lighting service, energy charges are excluded in the above rates.

TAXES AND FEES

Taxes and fees imposed by governmental authorities on the basis of meters or revenues shall be added to the monthly charge as applicable.

UP FRONT FEES AND DEPOSITS

There shall be no up front fees or deposits under this rate on the initial request for outdoor lighting. Deposits may be required by management when it is necessary to disconnect and reconnect service for non-payment.

METERED SERVICES

There shall be no separate metered services under this rate. See Outdoor Lighting Rate O-2 for metered services of Member owned lighting systems.

**RATE SCHEDULE – DECORATIVE LIGHTING
OUTDOOR LIGHTING**

APPLICABILITY

Applicable to all members for year-round outdoor lighting of yards, driveways parks, streetscapes and walkways where decorative lighting is desired. Lights should be at locations which are easily and economically accessible to Cooperative equipment and personnel for construction and maintenance and can be served by the Cooperative's underground distribution system.

The Cooperative will install and own the decorative poles, fixtures, brackets and other such hardware necessary for installation. Poles will be spun concrete or similar and luminaries shall be Acorn design or similar. The Member, developer or owner agrees to furnish an easement and necessary right of way for all Cooperative facilities. The Member agrees to permit any tree trimming required for service conductors and lighting units or units. The Member agrees that where he/she is the owner of the land, he/she will grant an easement to the Cooperative for the purpose of installing poles, lines and all necessary electrical connections. Where the Member is not the owner of the land, the Members agrees to procure the consent of the owner of said property, and where such consent is necessary, the Member agrees to procure the signature of the owner.

Single-phase, 60 cycles, at available voltages. Service includes lamps, energy from approximately dusk each day until approximately dawn the following day, and maintenance of facilities. MONTHLY CHARGES:

The following charge includes a spun concrete pole, a decorative Acorn fixture, and maintenance and energy costs.

12 foot concrete pole with fixture: \$24.00

No credit shall be allowed for lamp outages.

For lighting service, energy charges included in the above rates are based on wattage of the lamp X 12 hours per day operation X 30 days in the month.

TAXES AND FEES

Taxes and fees imposed by governmental authorities on the basis of meters, revenues, energy sold, or energy purchased shall be added to the monthly charge as applicable.

UP FRONT FEES AND DEPOSITS

There shall be no up front fees or deposits under this rate on the initial request for outdoor lighting. Deposits may be required by management when it is necessary to disconnect and reconnect service for non payment.

METERED SERVICES

There shall be no metered services under this rate. See Outdoor Lighting Rate O-2 for metered services of Member owned lighting systems.
