

PETITION TO INTERVENE

Switched Services, LLC (“Xspedius”), pursuant to Rules 25-22.039 and 28-106.205, Florida Administrative Code, hereby requests leave to intervene in this proceeding, and as grounds therefore states:

1. Xspedius is a telecommunications company lawfully doing business in the State of Florida whose regulated operations are subject to the jurisdiction of this Commission pursuant to Chapter 364, Florida Statutes.



3. Xspedius is a competitive local exchange company ("CLEC") that provides local exchange service in the State of Florida. Xspedius currently has an interconnection agreement with BellSouth and has an arbitration matter pending with respect to a successor agreement (Docket No.040130-TP). The scope of this docket and the ultimate resolution of some or all of the issues proposed by BellSouth might have an impact on Xspedius. BellSouth has requested that the Commission initiate this proceeding and ultimately approve proposed modifications to existing interconnection agreements. As a CLEC with an interconnection agreement with BellSouth, the substantial interests of Xspedius and its business operations in the State of Florida might be affected by the resolution of issues in this docket.

WHEREFORE, Xspedius respectfully requests that the Commission grant the Company leave to intervene for all legal purposes in this docket.
