

PETITION TO INTERVENE

NuVox, Inc. on behalf of its operating entities NuVox Communications, Inc. and NewSouth Communications Corp. (“NuVox-NewSouth”), pursuant to Rules 25-22.039 and 28-106.205, Florida Administrative Code, hereby requests leave to intervene in this proceeding, and as grounds therefore states:

1. NuVox–NewSouth is a telecommunications company lawfully doing business in the State of Florida whose regulated operations are subject to the jurisdiction of this Commission pursuant to Chapter 364, Florida Statutes.



3. NuVox-NewSouth is a competitive local exchange company (“CLEC”) that provides local exchange service in the State of Florida. NuVox-NewSouth currently has an

interconnection agreement with BellSouth and has an arbitration matter pending with respect to a successor agreement (Docket No.040130-TP). The scope of this docket and the ultimate resolution of some or all of the issues proposed by BellSouth might have an impact on NuVox-NewSouth. BellSouth has requested that the Commission initiate this proceeding and ultimately approve proposed modifications to existing interconnection agreements. As a CLEC with an interconnection agreement with BellSouth, the substantial interests of NuVox-NewSouth and its business operations in the State of Florida might be affected by the resolution of issues in this docket.

WHEREFORE, NuVox-NewSouth respectfully requests that the Commission grant the Company leave to intervene for all legal purposes in this docket.


