BAY COUNTY, a political subdivision of the State of Florida, hereby gives notice that it voluntarily withdraws as an Intervenor in this Docket.

On November 16, 2004, the Bay County Board of County Commissioners adopted Ordinance 04-33, which shall become effective when filed with the Secretary of State. The Ordinance established the Bay County Utility Regulatory Authority and adopted standards and procedures for regulating water and wastewater utilities operating within Bay County. Given that Bay County, through its new Utility Regulatory Authority, is now ready and able to exercise the regulatory jurisdiction it re-assumed on September 7, 2004, the County should no longer continue as a party in this Docket.
