Dear Ms. Bayo:

We are counsel for InterCept Communications Technologies, Inc. ("InterCept"). InterCept is a Georgia corporation headquartered at 3150 Holcomb Bridge Road, Suite 200, Norcross, Georgia 30071. InterCept was issued certificate number 7282 by the Florida Public Service Commission (the "Commission") to provide interexchange telecommunications services in Florida in Docket No. 990659 (the "IXC Certificate").

In accordance with Section 364.336 of the Florida Statutes, InterCept hereby submits its 2003 and 2004 Regulatory Assessment Fee returns and associated fees, including applicable statutory penalties and interest.

In addition, InterCept respectfully requests that the Commission cancel the IXC Certificate. Despite having received the IXC Certificate in 1999, InterCept never commenced the provision of telecommunications services in Florida (or in any other state). Because its business plans changed before it began provisioning any telecommunications services, no Florida customers will be adversely affected by the Commission's cancellation of the IXC Certificate.




