On August 12, 2004, Docket No. 040845-TX was established to address USA Telephone, Inc. d/b/a CHOICE ONE Telecom's (USA Telephone) violations of Section 364.183(1), Florida Statutes and Rule 25-4.0161, Florida Administrative Code. USA Telephone failed to remit the penalties and Regulatory Assessment Fees (RAFs), including statutory late payment charges, levied by Order No. PSC-04-0994-PAA-TX, issued on October 11, 2004. The Commission further ordered that if USA Telephone fails to pay the penalties and RAFs, including statutory late payment charges, within fourteen (14) days after the issuance of the Consummating Order, the company's competitive local exchange telecommunications (CLEC) Certificate No. 5647 shall be cancelled and USA Telephone shall cease and desist providing CLEC services in Florida. The Commission further ordered that the outstanding RAFs, including statutory late payment charges, be sent to the Department of Financial Services for collection and, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amounts. 2

<u>NOTICE OF PROPOSED AGENCY ACTION</u> <u>ORDER IMPOSING PENALTIES AND REQUIRING PAYMENT</u> <u>OF DELINQUENT REGULATORY ASSESSMENT FEES, OR CANCELING</u> <u>COMPETITIVE LOCAL EXCHANGE TELECOMMUNICATIONS CERTIFICATE</u>

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

I. Apparent Violation of Section 364.183(1), F.S., Access to Company Records

A. Case Background

USA Telephone Inc. d/b/a CHOICE ONE Telecom (USA Telephone) is a certificated competitive local exchange carrier (CLEC) based in Miami, Florida that provides competitive local telephone services in Florida. The company reported \$1,534,219.99 intrastate revenue on its Regulatory Assessment Fee (RAF) Return for calendar year 2002, and paid a RAF in the amount of \$687.00. In 2003, our staff notified USA Telephone that the company had been randomly selected for an audit of its 2002 RAF Return. As part of a RAF Return audit of randomly selected CLECs, our staff will verify that fees for operation of the Florida Relay Service (FRS) are collected and remitted to the Florida Telecommunications Relay, Inc. (FTRI)

as required by Rule 25-4.160, Florida Administrative Code (F.A.C.), Operation of Telecommunications Relay Services.

Our staff obtained satisfactory information from USA Telephone to complete the audit of the 2002 RAF Return. However, the company failed to provide our staff complete information regarding the collection and remittance of the FRS fees. Between February 2 and June 23, 2004, our staff made multiple attempts via e-mail, phone calls, and written correspondence to obtain a response from USA Telephone. On June 30, 2004, in a final attempt to obtain information, our staff sent correspondence via certified mail and facsimile advising the company that should it not respond, it may be subject to penalties. The certified mail receipt from the United States Post Office was signed by a company representative indicating delivery of our staff's letter on July 9, 2004. We find that the company has been adequately notified of its obligation to provide the requested information and has been given sufficient time to do so. As of the date of filing this Order, USA Telephone has failed to furnish this Commission with the requested information.

Our staff has estimated that USA Telephone may owe approximately \$1800, to the Florida Relay Service. The estimate is based on the per-line surcharge rates for 2002 through August 2004, using the number of lines the company reported serving in 2003.

B. Jurisdiction

Pursuant to Section 364.285(1), Florida Statutes (F.S.), this Commission is authorized to impose upon any entity subject to its jurisdiction a penalty of not more than \$25,000 for each day a violation continues, if such entity is found to have *refused to comply with* or *to have willfully violated* any lawful rule or order of this Commission, or any provision of Chapter 364, F.S.

Section 364.285(1), F.S., however, does not define what it is to "willfully violate" a rule or order. Nevertheless, it appears plain that the intent of the statutory language is to penalize those who affirmatively act in opposition to a Commission order or rule. See, Florida State Racing Commission v. Ponce de Leon Trotting Association, 151 So.2d 633, 634 & n.4 (Fla. 1963); c.f., McKenzie Tank Lines, Inc. v. McCauley, 418 So.2d 1177, 1181 (Fla. 1st DCA 1982) (there must be an intentional commission of an act violative of a statute with knowledge that such an act is likely to result in serious injury) [citing Smit v. Geyer Detective Agency, Inc., 130 So.2d 882, 884 (Fla. 1961)]. Thus, a "willful violation of law" at least covers an act of purposefulness.

However, "willful violation" need not be limited to acts of commission. The phrase "willful violation" can mean *either* an intentional act of commission or one of omission, that is *failing* to act. See, Nuger v. State Insurance Commissioner, 238 Md. 55, 67, 207 A.2d 619, 625 (1965) [emphasis added]. As the First District Court of Appeal stated, "willfully" can be defined as:

An act or omission is 'willfully' done, if done voluntarily and intentionally and with the specific intent to do something the law forbids, or with the specific intent to fail to do something the law requires to be done; that is to say, with bad purpose either to disobey or to disregard the law.

<u>Metropolitan Dade County v. State Department of Environmental Protection</u>, 714 So.2d 512, 517 (Fla. 1st DCA 1998) [emphasis added]. In other words, a willful violation of a statute, rule or order is also one done with an intentional disregard of, or a plain indifference to, the applicable statute or regulation. <u>See, L. R. Willson & Sons, Inc. v. Donovan</u>, 685 F.2d 664, 667 n.1 (D.C. Cir. 1982).

Thus, USA Telephone's failure to provide this Commission with the requested information meets the standard for a "refusal to comply" and "willful violations" as contemplated by the Legislature when enacting section 364.285, F.S.

"It is a common maxim, familiar to all minds, that 'ignorance of the law' will not excuse any person, either civilly or criminally." <u>Barlow v. United States</u>, 32 U.S. 404, 411 (1833); <u>see</u>, <u>Perez v. Marti</u>, 770 So.2d 284, 289 (Fla. 3rd DCA 2000) (ignorance of the law is never a defense). Moreover, in the context of this docket, all competitive local exchange telecommunication companies, like USA Telephone are subject to the rules published in the Florida Administrative Code. <u>See</u>, <u>Commercial Ventures</u>, Inc. v. Beard, 595 So.2d 47, 48 (Fla. 1992).

We find that USA Telephone's failure to provide the requested information regarding the FRS fees is a "willful violation" of Section 364.183(1), F.S., in the sense intended by Section 364.285, F.S.

C. Conclusion

This Commission is vested with jurisdiction over this matter pursuant to Sections 364.183, 364.285, and 427.704, F.S. Further, the amount of the proposed penalty is consistent with penalties previously imposed by this Commission upon other CLECs in previous dockets for similar apparent violations. Therefore, this Commission imposes a penalty in the amount of \$10,000 against USA Telephone Inc. d/b/a CHOICE ONE Telecom for its apparent violation of Section 364.183(1), F.S., Access to Company Records, and orders the company to submit the required information listed in Attachment "A" to this Order to the Division of Regulatory Compliance and Consumer Assistance.

II. <u>Apparent Repeat Violation of Rule 25-4.0161, F.A.C., Regulatory Assessment Fees;</u> Telecommunications Companies

A. Case Background

On December 12, 2003, the Division of the Commission Clerk & Administrative Services mailed the 2003 RAF return notice to USA Telephone. The company never responded. On February 20, 2004, the Office of General Counsel mailed a delinquent notice for the 2003 RAF via certified mail. As evidenced by the signed certified mail receipt, the company received the General Counsel's letter on February 23, 2004, but never responded. In one final attempt to collect, our staff mailed a notice on May 7, 2004, advising the company that if it fails to pay the 2003 RAF, plus statutory penalty and interest charges, it may be subject to further penalties. Again, the company never responded.

This is the second docket established against USA Telephone for the same apparent violation of Rule 25-4.0161, F.A.C. This Commission issued Order PSC-01-2380-AS-TX, December 10, 2001, Docket No. 011135-TX, <u>In Re: Cancellation by Florida Public Service</u> <u>Commission of Alternative Local Exchange Telecommunications Certificate No. 5647 issued to USA Telephone Inc. for violation of Rule 25-4.0161, F.A.C., Regulatory Assessment Fees; <u>Telecommunications Companies</u>, accepting the company's settlement offer of \$100 to resolve the company's apparent failure to pay RAFs.</u>

B. Jurisdiction

Pursuant to Section 364.285, F.S., this Commission may impose a penalty or cancel a certificate if a company refuses to comply with this Commission's rules or any provision of Chapter 364, F.S. Rule 25-4.0161, F.A.C., which implements Section 364.336, F.S., requires the payment of RAFs by January 30 of the subsequent year for telecommunications companies, and provides for late payment charges as outlined in Section 350.113, F.S., for any delinquent amounts.

C. Conclusion

This Commission is vested with jurisdiction over this matter pursuant to Sections 350.113, 364.285, 364.336, and 364.337, Florida Statutes. Further, the amount of the proposed penalty is consistent with penalties imposed by this Commission upon other CLECs in previous dockets for similar apparent repeat violations. Therefore, this Commission imposes a penalty in the amount of \$1,000 against USA Telephone Inc. d/b/a CHOICE ONE Telecom for its apparent repeat violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies, for not paying the 2003 Regulatory Assessment Fee.

This Order shall become final and effective upon issuance of a Consummating Order, unless a person whose substantial interests are affected by this Commission's decision files a protest that identifies with specificity the issues in dispute, in the form provided by Rule 28-106.201, Florida Administrative Code, within twenty-one (21) days of the issuance of the Proposed Agency Action Order. As provided by Section 120.80(13)(b), Florida Statutes, any issues not in dispute shall be deemed stipulated. If USA Telephone fails to timely file a protest and to request a Section 120.57, Florida Statutes, hearing, the facts shall be deemed admitted, the

right to a hearing waived, and the penalties shall be deemed assessed. If USA Telephone fails to submit the required information, and pay the penalties and Regulatory Assessment Fees, including statutory late payment charges, within fourteen (14) calendar days after the issuance of the Consummating Order, the company's CLEC Certificate No. 5647 shall be cancelled and the collection of the Regulatory Assessment Fees, plus statutory late payment charges, shall be referred to the Department of Financial Services for further collection efforts. If USA Telephone's certificate is cancelled in accordance with this Commission's Order, the company shall be required to immediately cease and desist providing competitive local exchange services in Florida. This docket shall be closed administratively upon either receipt of the required information, and the payment of the penalties and Regulatory Assessment Fees, including statutory late payment charges, or upon the cancellation of the company's CLEC Certificate No. 5647.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that USA Telephone Inc. d/b/a CHOICE ONE Telecom is hereby assessed penalties of \$10,000 for its apparent violation of Section 364.183(1), Florida Statutes, Access to Company Records and \$1,000 for its apparent repeat violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies, for not paying its 2003 Regulatory Assessment Fee. It is further

ORDERED that USA Telephone Inc. d/b/a CHOICE ONE Telecom is required to submit the required information listed in Attachment "A" to this Order to the Division of Regulatory Compliance and Consumer Assistance. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that should USA Telephone Inc. d/b/a CHOICE ONE Telecom fail to timely protest this Order, the facts shall be deemed admitted, the right to a hearing waived, and the penalty shall be deemed assessed. It is further

ORDERED that any protest must identify with specificity the issues in dispute. In accordance with Section 120.80(13)(b), Florida Statutes, issues not in dispute will be deemed stipulated. It is further

ORDERED that should USA Telephone Inc. d/b/a CHOICE ONE Telecom fail to timely protest this Order, payment of the \$10,000 and \$1,000 penalties, including statutory late payment

charges, must be received within fourteen calendar days after the issuance of the Consummating Order. It is further

ORDERED that if this Order is not protested and the penalties, including statutory late payment charges, are not received within fourteen calendar days of the issuance of the Consummating Order, the penalties and statutory late payment charges shall be referred to the Department of Financial Services for further collection efforts and the company shall be required to cease and desist providing competitive local exchange telecommunications services in Florida. It is further

ORDERED that if this Order is not timely protested, this Docket shall be closed administratively upon: 1) receipt of the company's information as listed in Attachment "A" to this Order; and 2) receipt of the \$10,000 and \$1,000 penalty payments, including statutory late payment charges; or 4) upon the cancellation of the company's competitive local exchange carrier Certificate No. 5647 and referral of the penalties to the Department of Financial Services for further collection efforts.

BY THE COMMISSION:

On October 11, 2004, we issued Order No. PSC-04-0994-PAA-TX. The main purpose of the original Order was to assess penalties of \$10,000 and \$1,000 against USA Telephone Inc. d/b/a CHOICE ONE Telecom (USA Telephone) for its apparent violation of Section 364.183(1), Florida Statutes, Access to Company Records and for its apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies, for not paying its 2003 Regulatory Assessment Fee (RAF). Furthermore, the Order required USA Telephone to submit the required information listed in Attachment A to the Order to the Division of Regulatory Compliance and Consumer Assistance.

However, due to a scrivener's error, reference to USA Telephone's required payment of RAFs was omitted from the sixth, seventh, and eighth ordering paragraphs. Likewise, the seventh and eighth ordering paragraphs erroneously read that the penalties shall be referred to the Department of Financial Services for further collection efforts. Therefore, the sixth, seventh, and eighth ordering paragraphs of Order No. PSC-04-0994-PAA-TX are amended to reflect that USA Telephone is required to pay RAFs, including statutory late payment charges, in addition to the \$10,000 and \$1,000 penalties. Additionally, the seventh and eighth ordering paragraphs of Order No. PSC-04-0994-PAA-TX are amended to reflect that the RAFs, including statutory late payment charges, shall be referred to the Department of Financial Services for further collection efforts, not the \$10,000 and \$1,000 penalties.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the sixth, seventh, and eighth ordering paragraphs of Order No. PSC-04-0994-PAA-TX are hereby amended to reflect that USA Telephone Inc. d/b/a CHOICE ONE Telecom is required to pay its Regulatory Assessment Fees, including statutory late payment charges, in addition to the \$10,000 and \$1,000 penalties. It is further
