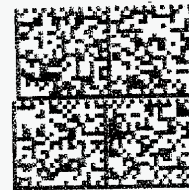

Dear Mr. Travis:

On October 6, 2004, the Commission received your letter dated October 2<sup>nd</sup> advising that Travis Communication Services is no longer in business as of September 17, 2004, which appears to be a request for cancellation of your pay telephone certificate. If that is the case, before staff can recommend a voluntary cancellation, the 2004 Regulatory Assessment Fee must be paid.

Commission rules provide that if a certificate is active for any day during a calendar year, the Regulatory Assessment Fee is owed for that year. Enclosed is a copy of the 2004 Regulatory Assessment Fee return form, which should be completed and returned with payment (the fee is .0015% of a company's intrastate revenues or \$50, whichever is greater).

As soon as the 2004 Regulatory Assessment Fee return form and payment are received, staff will establish a docket to process your request for cancellation. Please respond by November 3, 2004.
