#### APPLICATION FOR AMENDMENT TO CERTIFICATES OF AUTHORIZATION OF <u>CWS COMMUNITIES LP D/B/A PALM VALLEY UTILITIES</u> <u>TO DELETE AND AMEND PORTIONS OF ITS SERVICE TERRITORY</u>

CWS Communities LP d/b/a Palm Valley Utilities ("Utility"), holder of wastewater Certificate No. 223 - S and water Certificate No. 277 - W in Seminole County, pursuant to Fla. Admin. Code R. 25-30.036, by and through its undersigned attorney, hereby files this Application for Amendment to Certificates of Authorization of CWS Communities LP d/b/a Palm Valley Utilities to Delete and Amend Portions of its Service Territory ("Application"), and as grounds states:

1. The Utility's complete name and address are:

CWS Communities LP d/b/a Palm Valley Utilities 3700 Palm Valley Circle Oviedo, FL 32765

2. A complete legal description of the proposed territory using township, range and section references is attached hereto as Attachment "A."

3. One copy of a detailed system map showing the existing lines, treatment facilities, and territory served is attached hereto as Attachment "B."

4. There are no current active connections within the territory to be deleted. The territory to be added has been served by the Utility for 25 - 30 years, and the Utility had believed that this territory was included in the territory description contained in its tariffs.

5. Attached hereto as Attachment "C" is one copy of a map showing township, range, and section with a scale of 1" + 200', with the proposed service territory plotted thereon by use of metes and bounds or quarter sections, and with a defined reference point of beginning.

6. This application is being filed as a result of the Utility having been contacted by a developer requesting water and wastewater service for a 12.5 acre parcel, which the developer plans to develop into a subdivision with approximately 80 town homes. However, due to the lack of wastewater and water plant capacity, the Utility is unable to provide service as requested. The Utility has advised Seminole County Utilities Department that it will not be providing water and wastewater service to the development. Deletion of this territory by the PSC would be in the public interest because it would allow Seminole County Utilities to provide the requested service to the proposed development. In obtaining a legal description in order to delete this particular portion of property, it come to the Utility's attention that the composite legal description of the territory served which had been approved by the PSC over the years contains undeveloped property which the Utility does not intend to serve and which should be deleted from the service territory. It also came to the Utility's attention that certain parcels of property which have been receiving service from the utility for approximately 25-30 years, and which were assumed to be in the description of territory served, were not so described. These parcels need to be included in the approved certificated territory.

7. An original and two copies of the proposed water and wastewater tariff sheets reflecting the revised service area are attached hereto as Attachment "D."

8. CWS Communities LP d/b/a Palm Valley Utilities is currently a part of pending Docket No.030998-WS, Joint Application for Approval of the Transfer of Majority Organizational Control of Del Tura Phase I, LLC and CWS Communities LP as the Result of the

Acquisition by Hometown America, L.L.C. of the Stock of Chateau Communities, Inc. Docket No. 030998-WS is scheduled to go to Agenda on January 4, 2005.

9. The current, original Certificate Nos. 223 - S and 277 - W are currently on file at the PSC in order to be amended to show the utility's approved name change from CWS Communities LP d/b/a Palm Valley to CWS Communities LP d/b/a Palm Valley Utilities, as approved in Docket No. 040765.

10. The number of the most recent order of the Commission establishing or changing the Utility's rates and charges is PSC-02-1111-PAA-WS (Staff assisted rate case).

11. An affidavit that the Utility has tariffs and annual reports on file with the Commission is attached hereto as Attachment "E."

12. Pursuant to Sec. 367.145, Fla. Stat., an application fee in the amount of \$2000.00 made payable to the Florida Public Service Commission is attached hereto.

13. The affidavit required by Sections 367.045(1)(e) and (2)(f), Florida Statutes shallbe filed within 15 days after the filing of this Application pursuant to Fla. Admin. Code R. 25-30.030(8).

WHEREFORE, the Utility respectfully requests that the PSC approve this Application and such other relief as the PSC may deem appropriate.
