Dear Mr. Handerhan:

This is a follow up to our August 12th telephone conversation concerning your CLEC certificate. The Regulatory Assessment Fee is owed if a certificate is active for any day during a calendar year whether or not a company had any revenues or ever started operations during the periods covered. Talk and Pay, Inc.'s CLEC certificate became active in December 2002. This means the company owes the 2002, 2003, and now the 2004 Regulatory Assessment Fees, plus applicable statutory penalty and interest charges.

During our conversation, you indicated that you did not wish to keep Talk and Pay, Inc.'s CLEC certificate active. Based on this, in order to avoid an enforcement docket from being established, you need to write the Commission a letter and specifically request cancellation of the company's certificate. A copy of the cancellation rule is enclosed. In addition, I've enclosed a copy of the 2002, 2003, and 2004 Regulatory Assessment Fee return forms, which must be completed and returned with payment. If the company had no revenues, it would owe a total of \$189.00 (breakdown enclosed).

In addition to the above, I researched the Florida Department of State, Division of Corporations' records and found that Talk and Pay, Inc. was revoked on September 19, 2003, for not filing its annual report. If you wish to keep your certificate active, you would need to pay the 2002 and 2003 fees, plus applicable statutory penalty and interest charges, and reinstate the corporation with the Florida Department of State, Division of Corporations.

Please review this information and let me know the company's intentions. When returning payment and a copy of the completed Regulatory Assessment Fee return forms, please use the enclosed blue envelope, which will insure prompt processing. Please respond by August 31, 2004, to avoid additional late payment charges and an enforcement docket from being established.

Dear Mr. Handerhan:

The Regulatory Assessment Fee (RAF) is due by January 30th of each year for the preceding calendar year. For certificate holders, the RAF is owed even if a telecommunications company may not have started operations or had any revenues. Since payment has not been made, statutory penalty and interest charges are now applicable.

Our records show that the 2003 RAF return notice was mailed on December 12, 2003, and a delinquent notice was mailed on February 20, 2004. As of this date, our records do not show receipt of the RAF return or payment. A copy of the 2003 RAF return form is enclosed. If full payment, including penalty and interest charges, along with the RAF return form, are not received by May 28, 2004, a docket may be established. Your company may be fined or your certificate cancelled if you do not respond. Please note that once a docket has been established, **just paying the delinquent RAF amount will not prevent your certificate from being cancelled.**

If you wish to cancel your certificate voluntarily and leave in good standing with the Commission, your company should pay the past due amount in full, complete the 2003 RAF return form, either pay the 2004 RAF or provide a date certain it will be paid, and comply with the requirements of Rule 25-24.820, Florida Administrative Code, copy enclosed. Any unpaid RAFs, including penalty and interest charges, are turned over to collections. When returning payment and a copy of the completed 2003 Regulatory Assessment Fee return form, please use the enclosed blue envelope, which will insure prompt processing.

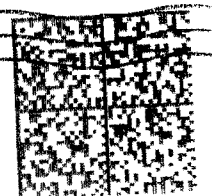

Dear Certificate Holder:

The Division of the Commission's Clerk and Administrative Services has forwarded your account to our office to address the nonpayment of the Regulatory Assessment Fees (RAFs) required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, for the year 2003, which was due January 30, 2004. The RAFs return form was mailed to you on **December 15, 2003**, and to date, Commission records reflect that payment has not been received.

According to Florida Law, you are required to add interest charges at 12% per annum, and a 5% penalty for each 30-day period or fraction thereof, beyond the due date, up to a maximum of 25% in addition to the delinquent amount due. In addition, pursuant to Section 364.285, Florida Statutes, the Commission is authorized to impose upon any entity subject to its jurisdiction a penalty of not more than \$25,000 for each offense, if such entity is found to have refused to comply with or to have willfully violated any lawful rule or order of the Commission, or any provision of Chapter 364.

Utilities are charged with knowledge of our rules and statutes. Moreover, it is general Commission practice that all utilities that apply for **Competitive Local Exchange** certificate receive a copy of all applicable rules. Further, in accordance with Section 364.335, Florida Statutes, as part of the application process, utilities provide an affidavit indicating that they have read and understood the applicable rules.

If you wish to request another form, please contact David Brown or Valorie Moore at the number below. The payment should be identified with the company code and the company's name. Failure to provide payment within **15 days of this notice** will result in the establishment of a docket to address your failure to return the RAFs form and pay RAFs in accordance with Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code. As specified above, pursuant to Section 364.285, Florida Statutes, the Commission may impose a fine or cancel your certificate. Therefore, it is important that you address this matter now.

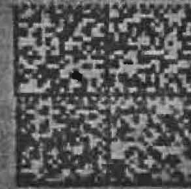
