Dear Ms. Bayo and Fiscal Services:

Crescent Telephone Company, Inc. has divested substantially all of its pay telephone assets and business and does not intend to operate or maintain any pay telephones in the State of Florida, nor to otherwise engage in any pay telephone services in the State of Florida, hereafter. The sale of Crescent Telephone Company, Inc.'s Florida pay telephones occurred during November 2004.

Accordingly, enclosed for early filing is Crescent Telephone Company, Inc.'s Pay Telephone Service Provider Regulatory Assessment Fee Return for calendar year 2004, together with a check in the amount of \$50.00 (minimum fee amount) in payment of the assessment fee required thereby. Additionally, enclosed is a corrected Change of Information on Regulated Utility form reflecting only our New York location and mailing address.


In light of the foregoing, Crescent Telephone Company, Inc. respectfully requests the following:

- (i) that Crescent Telephone Company's Certificate to Provide Pay Telephone Service in Florida (PATs certificate) number 8110 be cancelled or terminated, effective immediately; and
- (ii) that, also effective immediately, Crescent Telephone Company, Inc. be released from any and all further requirements or obligations to make reports or filings, or to participate in any applicable docket proceedings concerning pay telephones or pay telephone service in the State of Florida.

Kindly acknowledge receipt of this letter and the accompanying report by date stamping the attached duplicate copy of this letter and returning it to the undersigned in the pre-addressed, stamped envelope which has been provided for your convenience.

We look forward to receiving your written response to the foregoing requests and thank you in advance for your anticipated cooperation.
