PROGRESS ENERGY FLORIDA'S SECOND REQUEST  
FOR CONFIDENTIAL CLASSIFICATION

Progress Energy Florida ("PEF" or the "Company"), pursuant Section 366.093, Fla. Stats., and Rule 25-22.006, F.A.C., requests confidential classification of the redacted portions of contracts that PEF has with certain third parties that are contained in Bates ranges PEF-SR-02195 through PEF-SR-08610 and PEF-SR-08927 through PEF-SR-09009. The contracts in question were produced to the Staff of The Florida Public Service Commission ("Staff") in response to Staff's First Request for Production of Documents, Request 1. The portions of these contracts at issue contain competitive confidential pricing information of third-party contractors that PEF has contracts with. The unredacted contracts discussed above are being filed under seal with the Commission on a confidential basis to keep the competitive pricing information in those documents confidential.

Separate sealed boxes containing one copy of the confidential contracts for which PEF intends to request confidential classification with the appropriate section, pages, or lines containing the confidential information highlighted is enclosed herewith as Attachment "A." **This information should be accorded confidential treatment pending a decision on PEF's request by the Florida Public Service Commission.**

Additionally, two copies of the confidential contracts with the information that PEF intends to request confidential classification redacted by section page, or lines, are also included herewith as Attachment “B.”

### **The Confidentiality of the Information at Issue**

Section 366.093(1), Florida Statutes, provides that “any records received by the Commission which are shown and found by the Commission to be proprietary confidential business information shall be kept confidential and shall be exempt from [the Public Records Act].” § 366.093(1), Fla. Stats. Proprietary confidential business information means information that is (i) intended to be and is treated as private confidential information by the Company, (ii) because disclosure of the information would cause harm, (iii) either to the Company’s ratepayers or the Company’s business operation, and (iv) the information has not been voluntarily disclosed to the public. § 366.093(3), Fla. Stats. Specifically, “information... the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms” is defined as proprietary confidential business information. § 366.093(3)(d), Fla. Stats. Additionally, subsection 366.093(3)(e) defines “information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information,” as proprietary confidential business information.

Portions of the contracts produced to Staff in discovery should be afforded confidential treatment for the reasons set forth in the Affidavit of Jeff A. Dooley filed in support of PEF’s Second Request for Confidential Classification and for the following reasons. Portions of those contracts contain confidential, competitive pricing information of third-party contractors with which PEF has contracts.

PEF negotiates with third-party contractors to obtain competitive contracts for various goods and services that provide economic value to PEF and its ratepayers. Affidavit of Jeff A. Dooley at ¶5. In order to obtain such contracts, however, PEF must be able to assure those contractors that sensitive business information, such as the pricing terms of their contracts, will be kept confidential. Id. PEF has kept confidential and has not publicly disclosed confidential pricing terms in contracts that it has with third-party contractors. Id. Absent such measures, third-party contractors would run the risk that sensitive business information that they provide in their contracts with PEF would be made available to the public and, as a result, end up in possession of potential competitors. Id. Faced with that risk, persons or companies who otherwise would contract with PEF might decide not to do so if PEF did not keep those terms of their contracts confidential. Id. Without PEF's measures to maintain the confidentiality of sensitive terms in contracts between PEF and third-party contractors, the Company's efforts to obtain competitive fuel supply and transportation contracts would be undermined. Id. Additionally, the disclosure of pricing information in PEF's contracts would adversely impact PEF's competitive business interests. Id. If such information was disclosed to PEF's competitors or other potential contractors, PEF's efforts to obtain competitive contracts that provide economic value to both PEF and its ratepayers would be compromised. Id. The confidential portions of the contracts described above are treated as private and confidential by PEF and the information has not been disclosed and is not disclosed to the public. Id. at ¶6.

### **Conclusion**


The competitive, confidential contractual terms at issue in this request fit the statutory definition of proprietary confidential business information under Section 366.093 and Rule 25-

22.006, F.A.C. Attachment "C" hereto contains a justification matrix supporting PEF's request for confidential classification of the highlighted information contained in Attachment A.

WHEREFORE, PEF respectfully requests that portions of the documents more specifically described in Attachment C be classified as confidential for the reasons set forth above.


