Where panels are assigned the senior Commissioner is Panel Chairman: the identical panel decides the case.

Where one Commissioner, a Hearing Examiner or a Staff Member is assigned the full Commission decides the case.

In the last newsletter you solicited letters regarding our problems with the phone company because of their confusion as to where we live.


