Please file a revised transmittal letter making these corrections to show that each of the elements are included. With regard to the CLEC name in the adoption papers, please file an amendment indicating the correct name. The statutory deadline for this agreement is June 10, 2004, so I need to get a corrected letter as soon as possible. Please reply to this e-mail to let me know when I can expect to receive your corrected letter.
