Please identify each customer transfer that is due to existing uneconomic duplication of electric distribution facilities.
5. Are any of the proposed customer transfers due to avoiding future uneconomic duplication of electric distribution facilities? Please provide the criteria used to conclude that a transfer was most appropriate means to address future uneconomic duplication within the area of each such affected customer. Please identify each


